You are not our product. You are not our data. We believe privacy is not a feature, it is a position. We do not operate like the rest of the web. We do not hide meaning in legal noise. This is Mothrbox. We exist to protect and preserve what is human for this era.

#### What We Collect

We only take what you give us, intentionally.

We collect personal information such as name, email address, and other relevant data when you sign up for our services. We also collect usage data and technical information, such as device information and log data.

We don't need to know who you are to protect what you care about. We do not automatically collect:

- IP addresses
- Location
- Cookies`

There is no tracking here. No silent agreements. No invisible trades.

## What We Keep

Your data will be retained as long as you have an active account with us or as required by law. You can request to delete your data at any time.

We hold what must be held, for as long as it is needed and no more. There is no vault behind your vault. Our design favors forgetting.

We only retain:

- What you encrypt with intention.
- What you save explicitly.
- What is necessary to fulfill the function you've requested.

All else vanishes. Ephemeral by design.

#### What We Never Do

Some lines must not be crossed, not even if they're profitable. We don't trade in people. We do not use you to feed machines.

We will never:

- Sell or trade your data
- Use your content to train Al
- Share with third parties unless legally compelled
- Retain anything after you delete it

We do not know what you store. We do not want to know. That is the whole point.

## **Encryption**

We take data security seriously and employ modern encryption techniques (ECC NIST P-256) to protect your data. Only authorized users can access their data.

We take encryption very seriously. A private act of protection.

Which means:

- We cannot read what you encrypt
- We can't decrypt it, only you can.

• No one in the middle, including us, can see what's inside

#### **Your Control**

You have the right to access, correct, and delete your personal data. You can also object to the processing of your personal data.

You can also:

- Encrypt
- Decrypt
- Erase
- Exit

No hidden layers. No fine print.No tricks.

## **Legal Compliance**

If required by law, we may receive requests for information. In those cases, we will:

- Inform you when possible
- Resist overreach
- Only comply if compelled
- Only share what we have, which is often nothing

We design to hold little, so that there is little to take.

## **Changes to This Document**

We don't believe in silent changes. When we update this document:

- You will know
- We will explain why

• And you will still be free to leave

We believe in informed trust, not blind consent.
